I also understand that I may request a copy of Morris Hospital and Healthcare Center's Notice of Privacy Practices, or ask any other questions, by calling Morris Hospital and Healthcare Centers's AlertLine, at 1-800-93-ALERT, or the Medical Records Department of the Morris Hospital and Healthcare Centers where I receive treatment, at any time, in order to learn more about how information about me is used or disclosed by Morris Hospital and Healthcare Centers or about revocation of this authorization.

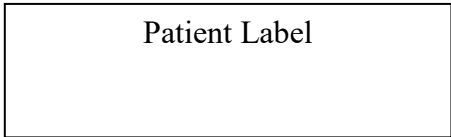

**\*\* Notice to Recipients of Alcohol & Drug Abuse Information:** The confidentiality of alcohol and drug abuse patient records maintained by Morris Hospital and Healthcare Centers, and disclosed to you pursuant to this under this authorization, is protected by Federal law and regulations (*see* 42 U.S.C. § 290dd-3 and 290ee-3, and 42 C.F.R. pt. 2). Generally, you may not further disclose the identity of the patient, or any information identifying the patient as an alcohol or drug abuser, unless: (a) the patient consents in writing (b) the disclosure is allowed by a court order; or (c) the disclosure is made to medical personnel in an emergency care situation or to qualified personnel for research, audit, or program evaluation purposes. Violation of Federal laws or regulations is a crime. Suspected violations should be promptly reported to appropriate authorities, in accordance with Federal regulations. Federal laws and regulations do not protect any information about a crime committed by a patient or about any threat to commit a crime.
